Little Mountain Elementary is committed to the goal of providing quality education for every child in this district. To this end, we want to establish partnerships with parents and with the community. Everyone gains if Little Mountain Elementary and home work together to promote high achievement by our children. Neither home nor Little Mountain Elementary can do the job alone. Parents play an extremely important role as children's first teachers. Support for their children and for the school is critical to children's success at every step along the way.

Little Mountain Elementary recognizes that some students may need the extra assistance available through the Title I program to reach the state's high academic standards. Little Mountain Elementary intends to include parents in all aspects of the school's Title I program. The goal is a school-home partnership that will help all students to succeed.

A. We meet with families in both evening, morning and throughout the day. Childcare is provided when possible. At Little Mountain Elementary we also do numerous home visits for a variety of reasons.

1. ***Teachers are available to meet with parents prior to and at the end of each school day. Teaching staff also have conferences twice yearly with all parents.***
2. ***Parents are made aware of their student's academic progress and proficiency levels at formal conferences and as needed when students' performance changes.***
3. ***Families are encouraged to meet with their teachers when any concerns arise around the academic, social or emotional success of their student..***

PART II-REQUIRED SHARED RESPONSIBILITIES FOR HIGH STUDENT ACADEMIC ACHIEVEMENT

As a component of the school-level Parent and Family Engagement policy, each school shall jointly develop with parents for all children served under this part, a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement.

-Conduct a parent/teacher conference in elementary schools, annually (at a minimum), during which the compact shall be discussed as the compact relates to the individual child's achievement.

Parent teacher conferences are held twice a year formally. However, parents and teachers conference throughout the year as needed to discuss student progress.

-Provide frequent reports to parents on their child's progress.

Parents are provided reports twice a year on their student's progress.

-Provide parents with reasonable access to staff, opportunities to volunteer and participate in their child's class and observation of classroom activities.

Parents are invited to volunteer and connect with the school community through a variety of events, in classroom experiences and welcome to be in the school throughout the day.

-Ensuring regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand.

We have a variety of ways to communicate between school and home. When communicating with families, we offer support in language translation both verbally and in writing.

BUILDING CAPACITY FOR PARENTS AND STAFF – REQUIREMENTS FOR ENGAGEMENT

To ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, **each school and district must:**

- 1) Assist parents in understanding the challenging State academic standards, how to monitor a child's progress, and work with educators.

Parents are provided with the progress of their student on both state and local assessments.

Parents have access to students' progress through meeting with teachers.

- 2) Provide materials and training to help parents to work with their children, such as literacy training and using technology (including education about the harms of copyright piracy).

Parents are provided materials at conferences, family engagement nights and Parent Group meetings.

Teachers present ways to assist their children at Parent Group meetings, conferences and family nights. Family Academies occur once per year, where families learn about how to access Skyward Information and assist their students in being successful.

- 3) Provide professional development to teachers, specialized instructional personnel, and other staff on the value of parents and their communities to increase academic achievement.

Staff are trained on how to conference with families in an engaging way, where they are learning about the families. Part of our equity work has had a focus on our engagement with the community and our families and through this engagement students are able to increase their academic achievements.

- 4) Coordinate and integrate parent engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parent engagement.

Our students and families have access to parent academies, after school programs (YMCA, Boys and Girls Club, and Children of the Valley), and we connect families with family resources at Catholic Community Services and Seamar.

- 5) Ensure that information related to school and parent programs, meetings, and other activities is sent to the parents of participating children in a format and, to the extent practicable, in a language the parents can understand.

All documents are translated and available in English, Spanish, Ukrainian, and Russian.

The following are allowable activities:

- 6) May involve parents in the development of training for teachers, principals, and other educators to improve the effectiveness of such training.

- 7) May provide necessary literacy training from funds received under this part if the district has exhausted all other reasonably available sources of funding for such training.

- 8) May pay reasonable and necessary expenses associated with local Parent and Family Engagement activities, including transportation and childcare costs, to enable parents to participate in school-related meetings and training sessions.
- 9) May train parents to enhance the involvement of other parents.
- 10) May arrange school meetings at a variety of times, or conduct in-home conferences between teachers or other educators, who work directly with participating children, with parents who are unable to attend such conferences at school, in order to maximize Parent and Family Engagement and participation.
We arrange school meetings before and after school. We also have home visits to provide families with the opportunity to conference on their students.
- 11) May adopt and implement model approaches to improving Parent and Family Engagement.
- 12) May establish a district parent advisory council to provide advice on all matters related to Parent and Family Engagement in programs supported under this section
- 13) May develop appropriate roles for community-based organizations and businesses in Parent and Family Engagement activities.
We connect with Catholic Community Services, Community Action, our local food bank, COV, and work with our Social Worker to connect families to resources.
